ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the online first appeal bearing No. PODEP/A/E/22/00051 dated 14.05.2022, preferred by Manish Kumar r/o H. No. 554, New Police Line, Sector-26, Chandigarh under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System(RTI-MIS), against the disposal of his RTI Application bearing No. PODEP/R/E/22/00223 dated 29.03.2022 by CPIO/Communication.

- The appellant, vide his RTI application dated 29.03.2022 under RTI Act 2005, had requested, CPIO/Communication to supply him some information in 06 points, about the entry made by Const. Manish Kumar 1027/CP (applicant) in log book and duty deployment in Communication Wing. CPIO/Communication disposed-of the RTI application, vide No. RTI-28/DSP/Comn./UT, dated 26.04.2022.
- The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal alleging that the CPIOs i.e. CPIO/Comm. and CPIO/Establishment has supplied misleading/incomplete information and has requested to provide the reply of 3,4,5 and 6th question of the RTI no. PODEP/R/E/22/00223.
- The comments of DSP-cum-CPIO/Communication have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by the CPIO. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
