ORDER

The appellant has preferred his 1st appeal dated 03.10.2023 against the disposal of his RTI applications dated 09.08.2023 by CPIO/ Hqrs with the contentions that the sought information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI applications dated 09.08.2023 had sought the investigation report, minute sheet alongwith action taken on letter No. 27211/AK/29 dated 14.03.2018 which was further sent to W/DGP from UT Administration vide No. 841-III(2)-2018/6068 dated 21.03.2018.

Comments of CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his from office CPIO/Central to supply the information pertaining to letter No. 841-III(2)-2018/6068 dated 21.03.2018 as the same is attached with complaint No. PW202003592 which is currently consigned in HAC branch after completion of enquiry. Thereafter, requisite information was obtained from concerned branch i.e. HAC and the sought information (consisting of 11 pages) was supplied to the appellant vide letter No. 534/CPIO/Hqrs/RTI-23, D-664 dated 13.09.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs. vis-à-vis material available on record which revealed that the appellant had sought the investigation report, minute sheet alongwith action taken on letter No. 27211/AK/29 dated 14.03.2018 which was further sent to W/DGP from UT Administration vide No. 841-III(2)-2018/6068 dated 21.03.2018.

In reply, CPIO/Central had transferred the RTI application to CPIO/Hqrs (being custodian of information) as letter No. 27211/AK/29 dated 14.03.2018 were attached with complaint No. 2020-03592 dated 24.02.2020 which is currently consigned in HAC branch after completion of enquiry.

Thereafter, CPIO/Hqrs obtained the requisite information from quarter concerned and the same (consisting of 11 pages) was supplied to the appellant as per RTI act.

So far as the appeal is concerned, sought information has already been provided to the appellant, yet to obtain the objective of RTI Act and in the interest of justice, CPIO/Hqrs is hereby directed to give an opportunity to the appellant to inspect the relevant complaint file and provide him remaining information, if any, in accordance with the RTI Act.

With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
