

**THE SENIOR SUPERINTENDENT OF POLICE, HQs.- CUM-APPELLATE AUTHORITY,
ESTABLISHMENT BRANCH AND COMMUNICATION, UNDER RIGHT TO
INFORMATION ACT, 2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the online first appeal bearing No. PODEP/A/E/22/00054 dated 21.05.2022 preferred by Sh. Pravasi Meet r/o 6A Bhattrubhav Society Pavanchakki road, Nadiad, Gujarat under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System(RTI-MIS), against the disposal of his RTI Application bearing No. PODEP/R/E/22/00325 dated 10.05.2022 by CPIO/Communication.

2) The appellant, vide his RTI application dated 10.05.2022 under RTI Act 2005, had requested, Nodal Officer/PHQ to supply him some information regarding total No of Police Stations and CCTV Cameras installed at Police Stations of U.T., Chandigarh. Nodal Officer PHQ transferred the said application to CPIO/Communication disposed-of the RTI application, vide No. RTI-37/DSP/Comn/UT/ Dated 18.05.2022.

3) The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal alleging that the. CPIO/Comm. has supplied incomplete information on point No. 01, 03 & 04.


4) The comments of DSP-cum-CPIO/Communication have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by the CPIOs. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

Point No. 04 CPIO has not disclosed recording capacity of installed CCTV cameras police station wise. Kindly disclose that how many police stations contain CCTV cameras having 15 days recording capacity and names of such police stations. Kindly disclose that how many police	

		stations contain CCTV cameras having 30 days recording capacity and names of such police stations. Kindly disclose that how many police stations contain CCTV cameras having 45 days recording capacity and names of such police stations.
