**ORDER**

The appellant has preferred online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00115 dated 06.10.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00769 dated 02.09.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application had sought information on 03 points regarding complaint bearing No. ICMS/2023/020498 i.e. certified copy of the complaint, copy of statements recorded and status report of the complaint.

**COMMENTS OF CPIO/Hqrs :-**

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from CPIO/East to supply the information regarding complaint bearing No. ICMS/2023/020498. Thereafter, requisite information was obtained from I/C CRU who reported that complaint in question is under consideration for finalization. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 291/CPIO/Hqrs/Online RTI-2023, D-227 Dated 26.09.2023.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information on 03 points regarding complaint bearing No. ICMS/2023/020498 i.e. certified copy of the complaint, copy of statements recorded and status report of the complaint.


In reply, CPIO/Hqrs had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaint in question was under consideration at that stage.

So far as the appeal is concerned, as per current status of ICMS Portal, complaint No. ICMS/2023/020498 dated 11.08.2023 has now been consigned to record in HAC branch after completion of enquiry. Hence, the requisite information can be supplied to the appellant.

Accordingly, CPIO/Hqrs is hereby directed to supply the requisite information to the appellant as per RTI act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
