ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 116/UT/RTI/FAA/SSP dated 26.10.2020.

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought information of three points i.e. current status, photocopies of statements recorded and copies of documents submitted regarding complaint No. PW 202009225.

DELAY IN FILING APPEAL:-

Appellant had filed appeal after the delay of 30 days from the date of disposal of his RTI application, therefore, vide letter No. D-421/UT/RTI/SSP dated 24.11.2021, he was asked to explain valid/cogent reasons for condoning of delay. In this regard no reply has been received to the undersigned till date.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, vis-à-vis material available on record which revealed that appellant had sought information of three points i.e. current status, photocopies of statements recorded and copies of documents submitted regarding complaint No. PW 202009225.

So far as the appeal is concerned, appellant had filed appeal after the delay of 30 days from the date of disposal of his RTI application, therefore, vide letter No. D-421/UT/RTI/SSP dated 24.11.2021 appellant has been asked to explain his valid reason for condoning of delay in appeal within 07 days positively, so that his first appeal can be entertained as per RTI Act, otherwise it would be assumed that you have nothing to say in the matter and appeal will be filed as "dismissed" without giving further opportunity. In view of above, no

reply has been received in this regard from your side. Therefore present appeal is hereby filed as "dismissed", appeal stand disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
