ORDER

The appellant has preferred her 1st appeal dated 05.11.2024 against the disposal of her RTI application dated 07.09.2024 by concerned CPIO/Admn with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought complete copy of report, along with all enclosures sent in August 2024 by SHO PS-19 to SDPO/East regarding premature release of Ravdeep Kaur R/o H. No. 159, Sector 20-A, Chandigarh.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information who reported that the report alongwith enclosures regarding pre-mature release of Ravdeep Kaur cannot be supplied to the appellant U/s 8(1)(h) of RTI Act, 2005 as the sought information would impede the process of investigation. The denial letter was sent to the appellant vide no. 158 & 309/RTI-24/DSP/Admn (O/o/SSP/UT) dated 07.10.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought complete copy of report, along with all enclosures sent in August 2024 by SHO PS-19 to SDPO/East regarding premature release of Ravdeep Kaur R/o H. No. 159, Sector 20-A, Chandigarh.

In reply, CPIO/Admn has denied the sought information as per the provisions of section 8(1)(h) of RTI Act.

Now as far as appeal is concerned, CPIO/Admn has inappropriately disposed of the RTI application, without going through the contents of the RTI application.

Now, the report regarding pre-mature release of Ravdeep Kaur has been consigned with HAC Branch after the finalization of the enquiry. Therefore, CPIO/Admn is hereby directed to provide the requisite information to the appellant as per RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
