ORDER

The appellant has preferred online 1st appeal bearing No. PODEP/A/E/23/00122 dated 10.11.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00858 dated 05.10.2023 by CPIO/Hqrs with the contentions that complete information be provided to him.

Information sought vide RTI application :-

The appellant vide his online RTI application had sought information on 07 points regarding directions of the Hon'ble CIC, New Delhi in case/appeal No. CIC/PODEP/A/2019/652053 & 652061 i.e. date of receiving of orders, copy of noting file, Name and Designation of official responsible for complying the directions, copy of efforts made by police for implementing the directions, date on which amount was awarded to the appellant and copy of the departmental action taken against the said responsible person.

COMMENTS OF CPIO/Hqrs:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information regarding case/appeal No. CIC/PODEP/A/2019/652053 & 652061 passed by the Hon'ble CIC, New Delhi. In this regard appeal has been initiated against the order dated 13.07.2023 in the Hon'ble Punjab & Haryana High Court, Chandigarh. Accordingly, appellant was apprised about the same in point was manner vide letter No. 311/CPIO/Hqrs/Online RTI-23, D-287 dated 03.11.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 07 points regarding directions of the Hon'ble CIC, New Delhi in case/appeal No. CIC/PODEP/A/2019/652053 & 652061 i.e. date of receiving of orders, copy of noting file, Name and Designation of official responsible for complying the directions,

copy of efforts made by police for implementing the directions, date on which amount was awarded to the appellant and copy of the departmental action taken against the said responsible person.


Thereafter, CPIO/Hqrs had apprised the appellant about the same information in point wise manner.

So far as the appeal is concerned, the information with regard to point Nos. 1 & 3 i.e. date of receiving of orders, Name and Designation of official responsible for complying the directions, the same information has already been provided to the appellant. Further, information in connection with point Nos. 4, 5, 6 & 7 i.e. copy of efforts made by police for implementing the directions, date on which amount was awarded to the appellant and copy of the departmental action taken against the said responsible person, appellant has already been apprised that an appeal has been initiated against the order dated 13.07.2023 passed by CIC, New Delhi in the Hon'ble Punjab & Haryana High Court, Chandigarh.

Moreover, as far as information pertaining to point No. 2 i.e. copy of complete noting file for taking necessary action upon the order/appeal of the Hon'ble CIC, New Delhi, CPIO/Hqrs has appropriately applied section 8 (1) (e) of RTI Act. Hence, no more action is required to be taken on the part of CPIO/Hqrs, as sought information is fiduciary in nature u/s 8 (1) (e) of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
