ORDER

The appellant has preferred 1st appeal dated 23.01.2024 against the disposal of his RTI application dated 05.12.2023 by CPIO/Central with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 05.12.2023 had sought information on 05 points regarding letter sent vide registered post no. EU887231466IN i.e. copy of complaint number registered on the letter, no. of days complaint was pending with concerned officers, copy of rules/notification for no. of days for marking/enquiry of complaint, rules/notification regarding not taking appropriate action on complaint and when will the enquiry be finalized upon this complaint.

COMMENTS OF CPIO/Central :-

CPIO/Central vide his comments submitted that RTI application of the appellant was received to provide the requisite information. Accordingly, requisite information was obtained from SHO-11 and reply was provided to the appellant in point wise manner vide no. 332/RTI-23/CPIO-Central/UT/dated Chandigarh the 28.12.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant had sought information on 05 points regarding letter sent vide registered post no. EU887231466IN i.e. copy of complaint number registered on the letter, no. of days complaint was pending with concerned officers, copy of rules/notification for no. of days for marking/enquiry of complaint, rules/notification regarding not taking appropriate action on complaint and when will the enquiry be finalized upon this complaint.

In reply, CPIO/Central has already provided information in point wise manner to the appellant.

Now as far as appeal is concerned, the appellant is not satisfied with the reply provided by the CPIO. However, CPIO has already provided the requisite information available on record with him to the appellant and no more information is pending with the CPIO. Henceforth, no more action is required to be taken on the instant appeal.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
