**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal dated 18.11.2024 against the disposal of his RTI application dated 10.10.2024 by concerned CPIO/Admn with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application had sought information on 03 points in regard to complaints bearing No. ICMS/2024/024538 and ICMS/024990 i.e. certified copy of inquiry report, certified copies of statements of all concerned and certified copies of order/ directions given by higher authorities to subordinate officers regarding inquiry alongwith copies of replies.

**COMMENTS OF CPIO/Admn :-**

CPIO/Admn vide his comments submitted that the RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC and the same was supplied to the appellant by hand containing 73 pages vide office letter No. 331 & 340/RTI-24/DSP/Admn dated 24.11.2024.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information in regard to complaints bearing No. ICMS/2024/024538 and ICMS/024990 i.e. certified copy of inquiry report, certified copies of statements of all concerned and certified copies of order/ directions given by higher authorities to subordinate officers regarding inquiry alongwith copies of replies.


In reply, CPIO/Admn has supplied the sought information to the appellant by hand containing 73 pages vide office letter No. 331 & 340/RTI-24/DSP/Admn dated 24.11.2024.

Now as far as the appeal is concerned, CPIO/Admn has already provided the available information in the shape of 73 pages by hand to the appellant. Hence, no more action is required to be taken on this instant 1<sup>st</sup> appeal.

However, RTI application was disposed off after the passing of provided prescribed period in the RTI Act. Therefore, CPIO/Admn is hereby advised to dispose of the RTI application within the stipulated time period.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
