ORDER

The appellant has preferred his 1st appeal dated 18.11.2024 against the disposal of his RTI application dated 25.09.2024 with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 04 points regarding complaint bearing no. ICMS/2024/017027 i.e. inquiry report alongwith all annexures, recording of pen-drive, legal opinion and present status of complaint.

COMMENTS OF CPIO/Admn:-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office for supplying the requisite information. Accordingly requisite information was obtained from I/C CRU who reported that complaint bearing No. ICMS/2024/017027 is under enquiry and RTI application was transferred to CPIO/Central vide no. 246/CPIO/Admn/RTI-2024 dated 23.10.2024.

COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office for supplying the requisite information. Accordingly requisite information was obtained from SHO PS-03 who reported that complaint bearing No. ICMS/2024/017027 is still under consideration and the same was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act vide no. 312/RTI-24/CPIO-Central dated 14.11.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn & Central vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought on 04 points

regarding complaint bearing no. ICMS/2024/017027 i.e. inquiry report alongwith all annexures, recording of pen-drive, legal opinion and present status of complaint.

In reply, CPIO/Central had denied the sought information as per the provisions of section 8 (1) (h) of RTI Act.

Now as far as the appeal is concerned, CPIO/Central has appropriately disposed of the RTI application as compliant no. ICMS/2024/017027 is still under enquiry and the requisite information cannot be supplied at this stage also. Hence, no more action is required.

However, RTI application was disposed off after the completion of prescribed period under the RTI Act. Therefore, CPIO/Admn & Central is hereby advised to dispose of the RTI application within the stipulated time period.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
