ORDER

The appellant has preferred 1st appeal dated 24.11.2023 against the disposal of his RTI application dated 18.08.2023 by CPIO/Central with the contentions that requisite information be provided to him.

Information sought vide RTI application :-

The appellant vide his online RTI application had sought information on 04 points i.e. copy of ownership of House No. 2213, Sector 15, Chandigarh, Copy of rent agreement, copy of request received by Police regarding tenant verification and copy of action taken report regarding complaint bearing No. ICMS/2023/020930.

COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office to supply the sought information. Thereafter, requisite information was obtained from SHO PS-03 and the same was provided to the appellant in point wise manner vide letter No. 222/RTI-23/CPIO-Central/UT/dated Chandigarh the:- 31.08.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 04 points i.e. copy of ownership of House No. 2213, Sector 15, Chandigarh, Copy of rent agreement, copy of request received by Police regarding tenant verification and copy of action taken report regarding complaint bearing No. ICMS/2023/020930.

Thereafter, CPIO/Hqrs had apprised the appellant about the same information in point wise manner.


So far as the appeal is concerned, the information with regard to point Nos. 1 & 2 i.e. copy of ownership of House No. 2213, Sector 15, Chandigarh, Copy of rent agreement, is concerned the same does not relates with Police Department. Further, information in connection with point No. 3 i.e. copy of request received by Police regarding tenant verification, appellant has

already been apprised that no tenant verification has been found received with Police Station 11, Chandigarh.

Moreover, as far as information pertaining to point No. 4 i.e. copy of action taken report regarding complaint bearing No. ICMS/2023/020930, CPIO/Central has denied the requisite information to the appellant u/s 8(1)(h) of RTI act as complaint in question was under inquiry at that stage . However, as per the record of ICMS Portal, complaint bearing No. ICMS/2023/020930 has been filed with HAC Branch after the finalization of the enquiry. Therefore, CPIO/Central is hereby directed to provide the sought information to the appellant as per the provision of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
