**ORDER**

The appellant has preferred 1<sup>st</sup> appeal dated 05.12.2023 against the disposal of his RTI application dated 10.11.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application dated 10.11.2023 has sought information on 03 points regarding complaint bearing No. ICMS/2023/003967 filed by his wife (Roshan) i.e. copy of the complaint, copy of report and copy of inquiry report.

**COMMENTS OF CPIO/Hqrs :-**

CPIO/Hqrs vide his comments submitted that RTI application was received in his office to obtain information regarding complaint bearing No. ICMS/2023/003967. Thereafter, requisite information was obtained from I/C CRU, who reported that complaint bearing No. ICMS/2023/003967 is under consideration with CRU Branch. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 656/CPIO/Hqrs/RTI-2023, D-847 Dated 20.11.2023.


**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant has sought information on 03 points regarding complaint bearing No. ICMS/2023/003967 filed by his wife (Roshan) i.e. copy of the complaint, copy of report and copy of inquiry report.

In reply, CPIO/Hqrs has denied the requisite information to the appellant u/s 8(1)(h) of RTI act as complaint in question was under inquiry at that stage.

As far as the instant appeal is concerned, as per ICMS portal (Integrated Complaint Management System) complaint bearing no. ICMS/2023/003967 has now been consigned with HAC Branch after completion of the enquiry. Therefore, CPIO/Hqrs is hereby directed to provide the requisite information to the appellant after obtaining consent from the complainant i.e. (wife of Mohd. Zakir), as per RTI Act.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
