

**THE SENIOR SUPERINTENDENT OF POLICE, HQs.- CUM-APPELLATE
AUTHORITY, COMMUNICATION, UNDER RIGHT TO INFORMATION ACT, 2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the first appeal dated 25/04/2022, preferred by Sh. Vinod Kumar R/o H.No 01, Near Dhillon Farm, Zirakpur, Punjab under RTI Act 2005, transferred to this office through the office of FAA-cum-Senior Superintendent of Police, U.T., Chandigarh against the disposal of his RTI Application dated 20.05.2022.

2) The appellant, vide his application dated 20.05.2022 under RTI Act 2005, had requested SSP/Public Information Officer, RTI Section Department, Sector-09, Chandigarh to supply him some information in 06 points pertaining a complaint which was registered on 27.April. 2022 by Mrs. Harpreet Kaur W/o Vinod Kumar on police control room by Dialing 100. Incharge, Public Window (PHQ)-cum-CAPIO transferred the RTI application to CPIO/Communication, CPIO/South and CPIO/East, vide no. 427/RTI/CAPIO(PHQ) /UT/PWS dated 24.05.2022 for supplying the part information and to dispose of the same at their own level being the custodian of information. CPIO/Communication disposed of the application vide No. RTI-50/DSP/Comm./UT dated 30.05.2022 by supplying the information on point 04 only. The undersigned is the First Appellate Authority in respect to CPIO/Communication only.

3) The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal requesting therein to share CCTV footage sought by him in his RTI Application dated 20.05.2022.


4) The comments of DSP-cum-CPIO/Communication have been called for. He has submitted that the RTI application of Sh. Vinod Kumar R/o H.No 01, Near Dhillon Farm, Zirakpur was transferred to his office to supply part information. He found that out of 06 points mentioned in original RTI application, only point no 04 (*i.e. What immediate action was taken by A.S.I of Sector, when he received a complaint through Police control room regarding a kidnapping case that was on police helpline no. By Dial on 100 or 112 by Harpreet Kaur W/o Vinod Kumar on immediate basis*) was related to his office and he had disposed of the RTI application by supplying part information on point No. 04, vide No RTI-50/DSP/Comm./UT dated 30.05.2022. In the present appeal the applicant has filed first appeal only against point No.06 (*i.e. Kindly share the details of White Honda City car in which the culprits kidnapped the victim and share the CCTV footage (Kidnapping Video) of that time*) which was not related to Communication Wing. Hence no action is required.

5) Decision of the undersigned being First Appellate Authority/Commn. is as under:-

On the perusal of instant appeal and comments of CPIO/Communication, undersigned is agree with the comments of CPIO/Communication that the Sh. Vinod Kumar (appellant) himself has addressed this appeal to Senior Superintendent of

Police, Traffic & Security, U.T., Chandigarh requesting therein "Please share CCTV Video footage of that vehicle White Honda City Car in which I was trapped by some culprits on 27 Apr 2022 near about 2:30 PM to 3:00 PM of sector 34-35 traffic light near to Police Station Sector-34, Chandigarh" which is against the point No. 06 of RTI application which was not related to Communication Wing. Therefore, the decision would be taken by the concerned First Appellate Authority who has dealt the point No. 06 of RTI. No more action is warranted by the undersigned, as this appeal has also been transferred by the SSP/UT to First Appellate Authority-cum-SSP/Security & Traffic for its disposal. The appeal is hereby disposed of.

6) The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
