ORDER

The appellant has preferred 1st appeal dated 04.12.2023 against the disposal of his RTI application dated 27.10.2023 by CPIO/South with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 27.10.2023 has sought action taken report on his complaint filed against unknown mobile number.

COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that RTI application was received in his office to obtain requisite information. Thereafter, comments from concerned SHO PS-34 was obtained, who reported that DDR No. 15 dated 23.05.2023 was lodged in this regard. After enquiry a report has already been sent to senior officers, which is still under consideration for further action. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 263/RTI-23/CPIO-South/Chandigarh Dated 24.11.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant has sought action taken report on his complaint filed against unknown mobile number.


In reply, CPIO/South has denied the requisite information to the appellant u/s 8(1)(h) of RTI act as complaint in question was under inquiry at that stage.

Now so far as the appeal is concerned, CPIO/South has rightly denied the requisite information to the appellant u/s 8(1) (h) of RTI act as the complaint in question is still under consideration.

However, for achieving the objective of RTI Act as well as for satisfactions of the appellant, CPIO/South is hereby directed supply the requisite information to the appellant as and when the enquiry into the complaint is finalized, as per RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
