### **ORDER**

The appellant has preferred 1<sup>st</sup> appeal dated 18.12.2023 against the disposal of his RTI application dated 21.11.2023 by CPIO/North-East & Hqrs with the contentions that requisite information were not provided to him.

#### Information sought vide RTI application :-

The appellant vide his RTI application dated 21.11.2023 had sought action taken report regarding complaints bearing Nos. ICMS/2023/021581 and ICMS/2023/022805.

## COMMENTS OF CPIO/North-East :-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office for supplying requisite information. Thereafter, requisite information was obtained from SHQ PS-IT Park who reported that complaint bearing No. ICMS/2023/022805 has been sent to senior officers after enquiry and complaint bearing No. ICMS/2023/021581 is still under consideration, hence, sought information was denied to the applicant as per provisions of section 8(1) (h) of RTI Act. Moreover, RTI application has already been transferred to CPIO/Hqrs and the appellant was informed accordingly vide letter No. 193 dated 22.11.2023 of RTI/CPIO/North-East/Chandigarh.

# COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information regarding complaint bearing No. ICMS/2023/022805. Thereafter, requisite information was obtained from I/C HAC who reported that complaint in question is consigned in with record after finalization. Thereafter, requisite information in the shape of 07 pages has been supplied to the appellant vide letter No. 675/CPIO/Hqrs/RTI-2023, D-926 dated 20.12.2023.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East & Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought action taken report regarding complaints bearing Nos. ICMS/2023/021581 and ICMS/2023/022805.

In reply, CPIO/Hqrs has already provided the sought information in the form of 07 pages to the appellant regarding complaint bearing No. ICMS/2023/022805 and CPIO/North-East had denied the requisite information pertaining to complaint bearing No. ICMS/2023/021581 to the appellant u/s 8(1)(h) of RTI Act as the complaint in question was under consideration at that stage.

Now so far as the appeal is concerned, CPIO/North-East has rightly denied the requisite information pertaining to complaint bearing No. ICM\$/2023/021581 to the appellant u/s 8(1) (h) of RTI act as the complaint in question is still under consideration.

However, for achieving the objective of RTI Act as well as for satisfactions of the appellant, CPIO/North-East is hereby directed supply the requisite information to the appellant as and when the enquiry into the complaint is finalized, as per RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
