This is an order in connection with First Appeal dated 24.06.2024, preferred by Sh. Tulsi Ram (retired Insp. No. 1154/CHG (ORP) R/o House No. 3363, Police co-op. House Building Society Sector- 51/D, Chandigarh under RTI Act 2005, received by hand in this office, against the disposal of his RTI Application dated 22.05.2024 by CPIO/Accounts & Procurement.

Facts:-

- 2. The applicant vide his RTI application dated 10.01.2024 had sought information in 05 different points pertaining to CPIO/Accounts, which are as under:-
- i) My Basic Pay fixed as on 01.01.2016.
- ii) Certified copy of my above Pay Fixation order.
- iii) Certified copies of the all pages of my Service Book (Complete Service).
- iv) Date of joining as well as retirement with rank of the following Police Officials: -
 - 1) Sat Pal No. 1381/CHG
 - 2) Surat Ram No. 2311/CP (NGO No. 1415/CHG)
 - 3) Ranpal Singh No. 1146/CHG
 - 4) Lakhbir Singh No. 1144/CHG
 - 5) Gurbaz Singh No. 1143/CHG
- v) Basic Pay of the above Police Officials as mentioned in Para No. 4 fixed by the Deptt. as on 01.01.2016.

- 3. The appellant is not satisfied with the information supplied by the CPIO/Acct. & Proc., vide no. 57/RTI/CPIO(Accts)/2024/UT/19116 dated 04.06.2024, against his RTI application dated 22.05.2024 and has filed the instant appeal alleging therein that "all the above five individuals were Government Servants in Chandigarh Police Department and the information sought by him is relating to their date of joining, retirement with rank from the Police Department as well as their basic pay fixed by the Department as on 01.01.2016 which is a Public Information being Public Servants. Therefore, you are requested to kindly listen my Appeal and provide the information question him please".
- 4. The Comments of CPIO/Accounts & Proc. were sought vide this office no. D-497/RTI/SP/Hqrs/UT dated 24.06.2024, who has intimated that the information sought by the applicant in 05 points, from which point No. 1 to 3 has already been provided to the applicant and point no. 4 & 5 was denied u/s 8 (1) (j) being third party information.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Accounts & Proc. The undersigned is satisfied with the reply/comment submitted by CPIO/Accounts. Therefore, no more action is required into the matter and the appeal is hereby disposed of, accordingly.
