ORDER

The appellant has preferred his 1st appeal dated 29.01.2024 against the disposal of his RTI application dated 22.12.2023 by CPIO/Central with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 22.12.2023 had sought information on 05 points regarding tenants residing at H. No. 12 (1st & 2nd Floor), Sector 15-A, Chandigarh i.e. personal information of all tenants submitted by the owner, copy of tenants Identity proofs with their correct address, documents submitted by landlord in compliance of Police Verification rules, copy of rent agreements and copy of offence made for non-submission of tenants verification record.

COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO PS- 11 who reported that sought information is third party and personal in nature. Hence, the same was denied to the appellant as per the provisions of section 8(1) (j) of RTI Act, 2005. Moreover, consent from Mr. Akhil Mehta (owner of 1st & 2nd floor) was obtained, who requested not to share the information. Applicant was apprised about the same vide letter No. 354/RTI-23/CPIO-Central/UT/dated Chandigarh the 01.01.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 05 points

regarding tenants residing at H. No. 12 (1st & 2nd Floor), Sector 15-A, Chandigarh i.e. personal information of all tenants submitted by the owner, copy of tenants Identity proofs with their correct address, documents submitted by landlord in compliance of Police Verification rules, copy of rent agreements and copy of offences made for non-submission of tenants verification record.

As far as appeal is concerned, CPIO/Central has appropriately denied the requisite information u/s 8(1) (j) of RTI Act after taking consent from the concerned party, information being third party and personal in nature. Hence, no more action is required to be taken upon this instant appeal.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
