**ORDER**

The appellant has preferred 1<sup>st</sup> appeal through e mail dated 01.01.2023 (which was addressed to total 9 First Appellant Authorities of different departments) received in this office on 05.01.2023 against the disposal of her RTI application dated 06.11.2022 (sent through e mail ) with the contentions that satisfactory information has not been supplied to her by CPIO vide his letter No. 320/RTI/2022, dated 04.02.2022.

**Information sought vide RTI application :**

The appellant vide her RTI application dated 06.11.2022 had sought information on total 09 points pertaining to complaints referred by her to various authorities including Chandigarh police . This RTI application of the appellant was addressed to total 9 CPIOs of different departments.

**Comments of CPIO/Central :-**

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office through CPIO/Hqrs vide his letter No. 711/CPIO/Hqrs/RTI-22,D-1010 dated 16.11.2022. Thereafter, requisite information was sought from SHO PS Sector 11, Chandigarh who reported that the so far as the information sought by the applicant in her RTI application from Police Department is concerned, the same found relates to action taken by local police on her complaints bearing PWS No. 2019-13586, 2019-21460 and 2019-19402 and all these complaints had already been sent to senior officers after enquiry. One more complaint having No. PMOPG/E/2019/0180589 which was registered vide Public Window No. 2019-08150 was also enquired and consigned to records in HAC branch. This information was conveyed to the applicant vide letter No. 320/RTI-22/CPIO-Central/UT, dated 04.12.2022 . Copy of this letter was also endorsed to CPIO/Hqrs for information.

**Comments of CPIO/Hqrs :-**

Before proceeding further in the matter, comments of CPIO/Hqrs were also obtained who submitted that RTI application of the appellant was transferred to his office from CPIO/Law & Prosecution Department, Chandigarh Administration vide memo No. LD(CPIO)-

2022/11623 & 11626 dated 15.11.2022 to supply the information. As the matter found relates to CPIO/Central and CPIO/South, accordingly, same RTI application was transferred to both CPIOs vide letter dated 16.11.2022. CPIO/Central vide his letter dated 04.12.2022 again intimated to him that matter pertains to enquiry into complaints bearing PWS Nos. 2019-13586, 2019-21460 and 2019-19402 and all these complaints had already been sent to senior officers after enquiry. One more complaint bearing No. PMOPG/E/2019/0180589 which was registered vide Public Window No. 2019-08150 was also enquired and consigned to records in HAC branch. Accordingly, all these complaints were called from HAC branch and after inspecting the files thoroughly by the applicant, requisite information was supplied to her in the shape of nineteen (19) pages vide letter No. 711/CPIO/Hqrs/RTI-2022, dated 12.12.2022.


**Decision :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central and CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant has mingled so many issues/grievances, RTI applications, appeals and complaints/reference in her instant appeal which are very difficult to understand as well as reply under RTI act.

However, CPIO/Hqrs after receiving relevant complaints bearing PWS No. 2019-13586, 2019-21460, 2019-19402 and 2019-08150 from HAC branch offered inspection of the files to the appellant, and supplied the requisite information to her in the shape of nineteen (19) pages vide letter No. 711/CPIO/Hqrs/RTI-2022, dated 12.12.2022.

As the requisite information has already been supplied to the appellant by CPIO/Hqrs. in the shape of nineteen (19) pages upto her satisfaction, so, no more action is required to be taken on the instant appeal and the same is hereby dismissed and disposed off accordingly. Furthermore, appellant is advised to not to mingle so many issues/grievances/ references in a single RTI application/appeal so that the same can be disposed off properly as per RTI Act.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
