ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the online first appeal bearing No. PODEP/A/E/22/00078 dated 29/06/2022, preferred by Sh. Ajay Kumar r/o H.No 5067 GF, Sector-38 West, Chandigarh under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his RTI Application dated 04/06/2022.

- 2) The appellant. vide his RTI application, bearing No. PODEP/R/E/22/00409 dated 04/06/2022 under RTI Act 2005, had requested, RTI Nodal Officer/PHQ to supply him some information in 03 points, pertaining to a visit of PCR at his Flat No. 5067, GF, Sector-38 West, Chandigarh. Nodal Officer, PHQ, further transferred the RTI application to CPIO/Communication, for disposal at his own level. CPIO/Communication disposed-of the RTI application, vide No. RTI-52/DSP/Comm./ UT dated 13.06.2022 and also transferred the RTI application to CPIO/South-West Division to supply part information & disposal at his own level.
- 3) The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal alleging that CPIOs has provided incomplete, misleading or false information.
- 4) The comments of DSP-cum-CPIO/Communication have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Communication. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
