ORDER

This is an order in connection with First Appeal dated 25.07.2024, preferred by of Sh. Harinder Pal Singh, Advocate, 1301 Sector-44-B, Chandigarh under RTI Act 2005, received against the disposal of his RTI Application dated 27.06.2024 by DSP/HQ-cum-CPIO/Establishment.

Facts:-

2. Vide his RTI application dated 27/06/2023, the appellant had sought information in 18 points from CPIO-cum-SDPO/East w.r.t. complaints ref. nos. PW202115885, ICMS/2024006141, ICMS/2024/008958, ICMS/2024/10983, ICMS/2024/10985 and ICMS/2024/016854. CPIO/East further transferred the RTI application to CPIO/Establishment, vide No. 107-RTI/CPIO/East dated 16.07.2024 for disposal the same at their own level. CPIO/Establishment dealt the part information w.r.t. points no. 10, 11, 12, 13, 14, 15 and same was disposed off vide no. 142/RTI-24/CPIO/Estt./UT/36582 dated 22.07.2024.

3. The appellant is not satisfied with reply/information supplied by the CPIO/Establishment and has filed the instant appeal mentioning therein that the information received from CPIO vide no. 128/RTI-24/CPIO/Estt./UT/36582 is not proper & complete.

4. The Comments of DSP-cum-CPIO/Establishment were sought vide No D- 579/R/RTI/SP/Hqrs. dated 25.07.2024, who intimated vide no. 128/RTI-24/CPIO/Estt./UT/37539 dated 30.07.2024 that points no. 10, 11, 12, 13, 14, & 15 pertains to their office and requisite information in these points relates to third party information. Moreover, ASI Naresh No. 1428/CP & HC Parvesh No. 1256/CP had given their written submission that their personal information cannot be disclosed. Hence, the requisite information against these points have been denied vide this office letter no. 128/RTI-24/CPIO/Estt./UT/36582 dated 22.07.2024.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Establishment. The undersigned is satisfied with the reply/comment of CPIO/Establishment that the requisite information could not be provided to the applicant being third party information under the provision of 8 (1) (j) of RTI Act 2005. Therefore, no more action is required in the matter and the appeal is hereby disposed off, accordingly.
