This is an order in respect of online First Appeal bearing no. PODEP/A/E/24/00053 dated 06/08/2024, preferred by of Sh. Rajneesh Bharara R/o H. No. 520 Preet Colony Zirakpur, Punjab under RTI Act 2005, received in this office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/24/00395 dated 18/06/2024 by CPIO/Establishment.

Facts:-

- Vide RTI application dated 18/06/2024 the appellant had sought 2. information in 06 points w.r.t. Recruitment of Constable (sports) in Chandigarh Police, which are as under :-
 - 1. Did your department recruited under Sports Quota for Karate Sports in year 2024.
 - 2. Was Karate Sports recognized by Ministry of Youth Affairs & Sports, Govt. of India & Indian Olympic Association at the time of recruitment?
 - 3. Were the players duly recruited were sent to the tournaments through Ministry of Youth Affairs & Sports, Govt. of India or through Indian Olympic Association?
 - 4. Were the certificates duly scrutinized by some Karate practitioner or senior Karate Master?
 - 5. In case any certificate found wrong submitted by the candidate so selected, what action will be initiated by your Department?
 - 6. Please supply the list of selected candidates under Sports Quota in year 2024?

The said RTI application was dealt by CPIO/Establishment and same was disposed of vide no. 118/RTI-24/CPIO/Estt. 36191 dated 16.07.2024.

- 3. The appellant, is not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant mentioning therein that the CPIO has provided Incomplete, Misleading or False Information.
- 4. The Comments in this appeal were sought from DSP/Hqrs-cum-The CPIO has intimated vide no. 118/RTI-24/CPIO/Estt/UT/38470 dated 09.08.2024 that the appellant had requested for information in 06 points w.r.t. recruitment of Constable (under Sports quota) in Chandigarh Police. Further, as per the report of the concerned branch i.e. E-2, the appellant has been intimated that the requisite information is available on the official website of Chandigarh Police and the same has been intimated to the applicant vide office letter no. 118/RTI-24/CPIO/Estt/UT/ 36191 dated 16.07.2024. However, the information against point no. 3 has been denied u/s 2 (f) of RTI Act 2005.

DECISION

I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority is satisfied with the reply/comments of CPIO/Establishment. Hence, no more action is required in the instant appeal. The appeal is hereby disposed off.
