## THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-ESTABLISHMENT, UNDER RIGHT TO INFORMATION ACT, 2005.

## ORDER

## Order on First Appeal u/s 19 RTI Act.

This is an order on an online appeal preferred by Sh. Jagjeet Singh R/o # 5080/2, Modern Housing Complex, Mani Majra, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/21/00064 dated 12.08.2021, against the disposal of his online RTI Application bearing No. PODEP/R/E/21/00373 dated 30.06.2021.

- (2) The appellant, vide his application dated 30.06.2021 under RTI Act 2005, had requested RTI Nodal Officer PHQ to supply him some information pertaining to his ACRs for the period from 01.04.2018 to 31.03.2021. CPIO/Establishment disposed of the RTI application online on 15.07.2021.
- (3) The appellant, not satisfied with the information as the same was incomplete, filed the instant online appeal aggrieving that the CPIO/Establishment has provided him incomplete, misleading or false information.
- (4) Comments of CPIO/Establishment have been called for. She has reported that the ACRs for the period of 1.04.2017 to 31.03.2018 and 01.04.2018 to 09.03.2019 were supplied to the appellant. However, the ACR of the period 2019-20 duly filled in by reporting officer, signed by reviewing officer has been sent to the accepting authority vide their office letter No. 29406/UT/E-II dated 02.09.2020 alongwith other 328 ACRs, out of which 305 ACRs have been received back but 24 ACRs are still pending with the accepting authority. Similarly, ACR for the period of 01.04.2020 to 31.03.2021 has been received from the reporting and reviewing officer and same has been further sent to accepting authority which is still awaited.
- (5) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

It is, therefore, requested that the appellant may be provided complete information i.e., copies of his ACRs of said period i.e., 1.4.2019 to 31.3.2020 & 1.4.2020 to 31.3.2021 at the earliest as matter is related to protection of life and service of the appellant.

CPIO/Establishment is directed to supply the copies of ACRs for the year 2019 to 2021, to the appellant whenever the ACRs received back from the accepting authority.

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
