This is an order in connection with First Appeal dated 30.12.2023, preferred by of Lalit Narang S/o Sh. Krishan Lal Narng R/o H No 1288/11, Mahinder Nagar, Ambala, Haryana under RTI Act 2005, received in this office through speed post against the disposal of his RTI Application dated 07.12.2023.

## Facts:-

- 2. Vide RTI application dated 07.12.2023, the applicant had sought information in 04 different point w.r.t. case FIR No. 185 Dated 06.11.2022 u/s 279 IPC registered in Police Station- 31, Chandigarh, which are as under :-
  - 1. That during the investigation of case FIR No. 185 Dated 06.11.2022 u/s 279 IPC registered in Police Station- 31 through letter no. 778/5A/Crime Branch, on 03.08.2023, Crime through CFSL, UT, Chandigarh. In this inspection, applicant and his son Karan Narang had taken part. During inspection CFSL has taken photos of inspection. Provide the certified photocopy of all photos taken by CFSL, UT, Chancigarh at inspection spot.
  - 2. Provide the certified CD / DVD / PAN / DRIVE of the inspection/examination which mentioned in column 1.

- 3. Provide the certified copies of all the documents of the inspection/examination which mentioned in column 1.
- 4. Provide the certified copies of final report of inspection/ examination which mentioned in column 1.
- 3. The appellant is not satisfied with the information supplied by the CPIO/Crime and has filed the instant appeal mentioning therein that the requisite information is helpful for him in a complaint no. ICMS/2023/020436 dated 10.08.2023.
- 4. The Comments of CPIO-cum-DSP/Crime were sought, vide No D-01 /RTI/SP/Hqrs. dated 02.01.2024, who intimated that the information sought by applicant is related with case FIR No. 185 dated 06.11.2022 u/s 279 IPC, PS-31, which is under trial in the Court of Sh. Karanvir Singh JMIC, UT, Chandigarh on 13.10.2023. Therefore, the requisite information could not be provided to the applicant, as no such, information is available with I/O of this case. However, the copy of challan has already been provided to the applicant.

## **DECISION**

I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Crime. The undersigned is satisfied with the reply/comment of CPIO/Crime that a copy of challan has already been provided to the applicant and no other requisite information is available with the I/O of this case. Hence, no more action is required in the matter and the appeal is hereby disposed of, accordingly.
