ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him and the same was diarized vide No. 05/UT/RTI/FAA/SSP dated 30.01.2022 for further proceeding under RTI Act.

## INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 03 points i.e. copy of all rules and regulations under which I.O. can hold an complaint without investigation, all rules regulations, notification under Chandigarh Police under which SHO can hold investigation and all rules and regulations under which I.O. can held responsible for not doing investigation.

## COMMENTS OF CPIO/SOUTH: -

Comments of CPIO/South submitted that from the perusal of RTI Act it is clear that appellant has raised grievances and RTI act is not a grievance redressal or problem solving mechanism, therefore, sought information does not falls under the provision of section 2 (f) of RTI Act. Hence, denied. Appellant has been apprised about the same vide memo No. 01/CPIO/South dated 04.01.2022.

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 03 points i.e. copies of all rules and regulations under which I.O. can hold an complaint without investigation, all rules regulations, notification under Chandigarh Police under which SHO can hold investigation and all rules and regulations under which I.O. can held responsible for not doing investigation.

Insofar appeal is concerned, appellant has sought information likes rules & regulations, acts and notifications under which investigating officer conducting investigation etc. As such, requisite information is academic in nature and also available in public domain i.e. Chandigarh Police website. Moreover, Chandigarh Police is functioning under Punjab Police Act 2007 (as applicable in Chandigarh) & Punjab Police Rules, Indian Penal Code, Cr.PC, Indian Evidence Act and other laws as notified by Punjab Govt. and Govt. of India. Hence, appellant can visit Chandigarh police website {http://chandigarhpolice.gov.in} for obtaining such rules and regulations under which Chandigarh Police is supervising its investigation work. With these observations, the instant appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
