**ORDER**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on the online first appeal bearing No. PODEP/A/E/22/00090 dated 04.08.2022, preferred by Sh. Ajay Kumar r/o H.No 5067 GF, Sector-38 West, Chandigarh under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his RTI Application dated 17.06.2022.

2) The appellant, vide his RTI application, bearing No. PODEP/R/E/22/00457 dated 19.06.2022 under RTI Act 2005, had requested RTI Nodal Officer/PHQ to supply him some information in 02 points, pertaining to a visit of PCR at his Flat No. 5067, GF, Sector-38 West, Chandigarh. Nodal Officer, PHQ, further transferred the RTI application to CPIO/Communication and CPIO/PCR for disposal at their own level. CPIO/Communication disposed-of the RTI application, vide No. RTI-60/DSP/Comm./U.T. dated 23.06.2022 and also transferred the RTI application to CPIO/PCR to supply part information & disposal at his own level. The undersigned is the Appellate Authority w.r.t. CPIO/Communication only.

3) The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal against alleging that CPIOs has provided incomplete, misleading or false information.

4) The comments of DSP-cum-CPIO/Communication have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Communication. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

ASI Jaswinder Singh 1501/CHG, I/C PCR vehicle reported that complainant lady Aarti age 44 years R/o # 5067, GF, Sector-38 West, Chandigarh, against her husband Ajay Kumar age 45 Yrs R/O same none injured. Spot handed over to ASI Tatwinder Singh 1638/CHG PS Maloya.	Sir, यह appeal दोनों RTI Application PODEP/R/E/22/00457 and PODEP/R/E/22/457/1 के लिए है।  <b>Point No. 1</b> मुझे इस reply के Point No-1 में यह नहीं बताया गया की Lady को दिक्कत क्या थी और PCR Call करने वाले के बारे जानकारी तथ्यों को छुपाने के लिए नहीं दी गयी।	On perusal of comments, the undersigned found that only point No. 01 of RTI application was dealt by CPIO/Communication. CPIO Commn. had also transferred the point No. 02 of RTI application to CPIO/PCR on 20.06.2022 to supply information at his own level. Therefore, the instant appeal has also been transferred to SSP/UT being First Appellate Authority w.r.t. CPIO/PCR vide this office letter No. D-620/RTI/SSP/HQs. dated 18.08.2022 for disposal the appeal against point No. 02 at his own level.  <b>Decision of the undersigned being the First Appellate Authority Commn. is as under:-</b> The undersigned is agree with the information supplied by the CPIO/Commn. on point No 01 of the RTI Application.
