This is an order on online First Appeal bearing no. PODEP/A/E/24/00059 dated 21/08/2024, preferred by of Sh. Ram Prasad, R/o VPO Mundahera, Tehsil- Salhawas, District- Jhajjar, Haryana Pincode- 124146 under RTI Act 2005, received in this office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing vide No. PODEP/R/E/24/00486 dated 17.07.2024 by CPIO/Communication.

Facts:-

2. Vide RTI application dated 17/07/2024, the appellant had sought information in 25 points from PIO, which was further marked by CAPIO(PHQ) to CPIO/Communication & CPIO/East, vide No. 683-RTI/CAPIO(UT)/PWS dated 15.07.2024 for disposal the same at their own level. CPIO/Communication has dealt the part information w.r.t. point nos. 5,6,11,12,17,18,19,20,25 and same was disposed off vide no. RTI-38/CPIO/Comn./UT dated 12.08.2024. The undersigned is the First Appellant Authority w.r.t. CPIO/Communication, only.

3. The appellant is not satisfied with reply/information supplied by the CPIO/Communication vide no. RTI-38/CPIO/Comn./UT dated 12.08.2024 and has filed the instant appeal mentioning therein that " *CPIO provided incomplete, misleading or false information*".

4. The Comments of DSP-cum-CPIO/Communication were sought online through RTI Request & Appeal Management Information System (RTI-MIS), who intimated that the part information w.r.t. point Nos. 5,6,11,12,17,18,19,20,25 has already been provided to the applicant through online portal in pdf format on 12.08.2024 and other points were related to DSP-cum-CPIO/East.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of DSP-cum-CPIO/Communication. The undersigned being First Appellant Authority/Communication is satisfied with the reply/comments of CPIO/Communication. Furthermore, part appeal has also been transferred to SSP/UT-cum-FAA w.r.t. CPIO/East for disposal her own level (copy attached). Hence no, further action is required w.r.t. CPIO/Communication in the instant appeal. The appeal is hereby disposed off.
