ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him and the same was diarized vide No. 06/UT/RTI/FAA/SSP dated 02.02.2022 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 06 points i.e. certified copies of file notings, copy of date and time when complaint was transferred, name of I.O., action taken report, certified copies of statements recorded and copy of status report in complaints No. 20214213 and 20214268.

COMMENTS OF CPIO/Central : -

Comments of CPIO/Central submitted that report from SHO-17 has been obtained who submitted that point wise reply of RTI has been prepared and delivered to the applicant vide 426, 429, 432 & 455/RTI-21/CPIO-Central/UT/dated Chandigarh the 16.12.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 06 points i.e. certified copies of file notings, copy of date and time when complaint was transferred, name of I.O., action taken report, certified copies of statements recorded and copy of status report in complaints No. 20214213 and 20214268.

In reply, CPIO/Central has provided the point-wise reply to the applicant. As far as the appeal in hand is concerned, CPIO/Central has rightly provided the point-wise information to the appellant regarding all points i.e. copy of file notings, copy of date and time when complaints were transferred and name of I.O. in complaints.

As far as point nos. 04-06 are concerned, i.e. action taken report, certified copies of statements recorded and copy of status report in the said complaints. CPIO/Central has appropriately denied the sought information to the appellant as complaints in question are still under inquiry.

With these directions, appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
