

**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE
AUTHORITY-HQs., UNDER RIGHT TO INFORMATION ACT, 2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated 01.09.2021, preferred by Sh. Joginder Singh R/O H.No 553/1, Sector-38/A, Chandigarh under RTI Act 2005, transferred to this office by First Appellate Authority-cum- SSP/UT, Vide No. D-350/UT/RTI/FAA/SSP dated 22.09.2021, against the disposal of RTI Application bearing No. JSC-17/2021/30 dated 20.07.2021.

(2) The appellant, vide his application dated 20.07.2021 under RTI Act 2005, had requested CPIO/HQs to supply him some information relating to complaints against DSPs, transfers policy, details of drivers of Chandigarh Police and posting of Home-guards of Chandigarh Police, in 05 points. In-charge Public Window (PHQ)-cum-CAPIO/Police Headquarters UT, Sector-09, Chandigarh had transferred the RTI application to CPIO/Estt., Accounts, PEB, Lines and CPIO/Distt. Commandant Home Guards, vide no. 732/RTI/CAPIO (PHQ)/UT/PWS dated 27.07.2021, being the custodians of the information sought in the RTI application.

(3) The appellant is not satisfied with the manner CPIOs disposed of his RTI application and filed the instant appeal alleging therein that CPIOs has provided him incomplete information.


(4) The comments of CPIO/Establishment, PEB, Lines and Accounts have been called for. The information sought by the appellant, information supplied by the CPIOs and points-wise decision of the undersigned being first appellate authority are as under:-

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
