ORDER

The appellant has preferred his 1st appeal dated 10.01.2025 against the disposal of his RTI application dated 29.11.2024 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 02 points i.e. if any email dated 06.03.2021 is received at your office email id i.e. dgp-chd@nic.in from email id i.e. anujkarol@gmail.com & if yes, then kindly provide certified copy of complaint, final report and outcome of investigation carried in the above email.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that the RTI application was received in his office to obtain the requisite information. After scrutiny of record, it was found that an e-mail was received from email id anujkarol@gmail.com on 06.03.2021 and in response, a revert e-mail was sent for providing complete information regarding matter, which happened in the jurisdiction of Chandigarh, but no such information was provided by the appellant. Therefore, no action was taken on the email dated 06.03.2021. The appellant was apprised about the same vide no. 588/CPIO/Hqrs/RTI-24, D-838 dated 18.12.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding 02 points i.e. if any email dated 06.03.2021 is received at your office email id i.e. dgp-chd@nic.in from email id i.e. anujkarol@gmail.com & if yes, then kindly provide certified copy of complaint, final report and outcome of investigation carried in the above email.

In reply, CPIO/Hqrs has apprised the appellant that no action was taken on the email dated 06.03.2021 for not providing complete information regarding the matter.

Now as far as the appeal is concerned, CPIO/Hqrs has already apprised the appellant that no action is taken on the email dated 06.03.2021 as no reply was provided by the applicant on the revert e-mail sent for providing complete information regarding matter. However, appellant is not satisfied with the provided information and has preferred 1st appeal. Therefore, considering the contentions of the applicant, CPIO/Hqrs is hereby directed to provide the copy of e-mail sent by the applicant and the copy of reverted e-mail made to the applicant as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
