ORDER

This is an order on First Appeal preferred by Smt. Anju Rathi W/o Suresh Kumar R/o # 90, Parvati Enclave, Baltana, Zirakpur, Mohali - 140604 under RTI Act 2005, received from the o/o SSP/UT on 28.08.2023. The appeal is filed against the disposal of her RTI Application 18/07/2023 by CPIOs of Chandigarh Police.

- The appellant, vide her application dated 18/07/2023 under RTI Act 2005, had requested to supply some information on 08 different points pertaining to recruitment of constables in the year 2010. The said RTI application is found dealt by DSP/Hqrs-cum-CPIO/Establishment, Accounts, PEB and East Division. However, out of 08 points only points nos. j, k, o, p & q were dealt by DSP/Hqrs-cum-CPIO/Establishment, Accounts and PEB. The undersigned is the First Appellate Authority w.r.t. CPIO/Establishment, Accounts and PEB. The appeal w.r.t. CPIO/East Division has already been transferred to the SSP/UT-cum-FAA/East Division, vide this office letter No. D734/R/SP/HQs. Dated 07.09.2023, for part disposal of appeal at her own level.
- (3) The appellant is not satisfied with the manner CPIOs had disposed of his RTI application, filed the instant appeal alleging that all the CPIOs has provided incomplete information. The comments of CPIO/Establishment, Accounts and PEB have been called for.

(4) I have gone through the information sought by the appellant and the information supplied the CPIOs. The appellant has been heard on dated 18.09.2023 in the office of undersigned, during the hearing she has submitted that the information supplied by the CPIOs are not certified and the points no. m & n of her RTI application were left undealt. The points-wise decision of the undersigned being first appellate authority is as under:-
