**ORDER**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on an online appeal preferred by Sh. Jaswant Singh O/o SDPO East, Sector- 26, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/21/00074 dated 17/09/2021, against the disposal of his online RTI Application bearing No. PODEP/R/E/21/00471 dated 19/08/2021.

(2) The appellant, vide his application dated 19/08/2021 under RTI Act 2005, had requested Nodal Officer-RTI, Chandigarh Police Headquarters to supply him some information related to detail of preparation of arrear of batch 2005. Nodal Officer/PHQ, further transferred the RTI application to CPIO/Accounts, who had disposed of the RTI application vide No. 46/RTI/CPIO (Accts)/2021/U.T/15194 dated 15.09.2021. The appellant not satisfied with the information supplied to him, has filed instant appeal aggrieving that the CPIO/Accounts has declined to supply the information under provision of section 8(1) (e) of RTI Act-2005.

(3) The comments of DSP-cum-CPIO/Accounts have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Accounts. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

Earlier I have filed a RTI application vide Registration No. PODEP/R/E/21/00118 vide which I sought information regarding detail of preparation of arrear amount by stepping-up the pay provided to the batch 2003 & 2005 and reason for contradictions therein. <b>But, I have only provided the detail of my own arrear, but no such detail has been provided for the batch 2005. During process of my 1st appeal into the earlier RTI application, the CPIO got inspected the file in which no arrear detail of 2005 was available and having only comparison detail of pay between 2005 &amp; 2008. So, the matter has not been sorted out even in 1st appeal. Thus, applying another RTI application. Therefore, it is requested that detail of preparation of arrear of</b>	The requisite information reg. to provide the details of preparation of arrear of batch 2005 has no relationship to any public activity or interest. Hence, the requisite information cannot be provided and denied under section 8(1) (e) of RTI Act, 2005.	Sir, It is submitted that I have filed a RTI application vide Registration No. PODEP/R/E/00471 dated 19.08.2021 which has been disposed off by the CPIO by declining the sought information under provision of section 8(1)(e) of RTI act whereas the seeking information has larger public interest, being relating to all officials (ORs) senior to batch 2005. It has already mentioned by me in my above said as well earlier RTI application (No. PODEP/R/E/21/00118) regarding difference in preparation of arrear amount, given to the officials	On perusal of RTI content, it is found that the appellant himself submitted that his arrear details had already provided to him against his earlier RTI application. Now, the appellant is seeking information related to details of preparation of arrear of batch 2005 which has no relationship to any public activity or interest. Hence, I agree with the information supplied by the CPIO.
