This is an order in online First Appeal bearing no. PODEP/A/E/24/00001 dated 01/01//2024, preferred by of Sh. Ravi Kant R/o Village - Mudain, PO - Sundrah, District - Mahendergarh, Haryana under RTI Act 2005, received in this office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/23/00893 dated 18/10/2023 by CPIO/Establishment.

Facts:-

2. Vide RTI application dated 18/10/2023, the appellant had sought information w.r.t. recruitment of constable in Chandigarh Police (executive) 2023, which is as under :-

"I had given the Chandigarh Police exam on 23.07.2023. I have need duplicate copy of exam omr sheet for confirmation the actual mark".

The said RTI application was dealt by CPIO/Establishment and same was disposed of vide no. 261/RTI-23/CPIO/Estt. 44242 dated 21.11.2023.

3. The appellant, is not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant mentioning therein that *"Provided incomplete, misleading or false information."*

4. The Comments in this appeal were sought from DSP/Hqrs-cum-CPIO/Establishment, who intimated that the appellant vide his RTI application had requested to supply his OMR Sheet of constable recruitment exam-2023 in Chandigarh Police. As per the reports of the concerned branch i.e. E-2, the appellant has been advised to visit the official website of Chandigarh Police, vide office letter no. 261/RTI-23/CPIO/Estt/UT/ 44242 dated 02.11.2023.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority found that the CPIO has disposed of the RTI application while the recruitment was in under process. Moreover, CPIO/Establishment in her comments has submitted that the record of Constable recruitment 2023 is in the custody of Recruitment Cell. Therefore, CPIO/Establishment is hereby directed to transfer the RTI application to CPIO/Recruitment to supply a fresh reply to the applicant as per record. The appeal is hereby disposed of.
