ORDER

This is an order on online First Appeal bearing no. PODEP/A/E/23/00039 dated 25/05/2023, preferred Rishipal R/o Street No. 02, Narender Nagar, Sonipat, Haryana under RTI Act 2005, received in office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his RTI Application bearing No. PODEP/R/E/23/00314 dated 22/04/2023 being dealt by CPIO/Trg. & Recruitment.

Facts:-

2. Vide RTI application dated 22/04/2023, the appellant had sought information in connection with ongoing recruitment of 700 Constables in Chandigarh Police dealt by CPIO/Trg. & Recruitment and disposed of the same, vide No. RTI-05/CPIO/Trg. & Recruitment dated 13.05.2023.

3. The Comments of DSP-Cum-CPIO/Rec. & Trg. were sought through online portal Request & Appeal Management Information System (RTI-MIS), who has intimated that the applicant vide his RTI application had sought the information in two points i.e. "1. *Whether a pregnant selected candidate for police constable can participate in the training.* 2. *Whether a candidate with the*

disease named as hepatitis C be eligible for the post of constable". As the mentioned points found related to health/physical issues (Pregnant & Hepatitis C), thus the same application was transferred to CPIO/Government Multi Specialty Hospital, Sector- 16, Chandigarh by CPIO/Establishment.

DECISION

5. The undersigned gone through the appeal filed by the appellant viz-a-viz comments of CPIO/Trg. & Rec. From the perusal of RTI application, it is found that the appellant has sought information i.e. "whether a selected candidate who is pregnant or suffering from Hepatitis C disease is eligible for training/joining as Constable".

In view of above, CPIO/Establishment and CPIO/Rectt. & Trg is hereby directed to check whether such information is available on records and supply afresh reply to the applicant accordingly. The appeal is dispose of accordingly.
