#### ORDER

\* \* \* \* \* \* \*

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 12/UT/RTI/FAA/SSP dated 11.02.2021 for further proceeding under RTI Act.

#### INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 03 points i.e. Action taken on the complaint Mr. Ankush Chabra by Lt Col MS dhanoa dated on 04 oct 2020, action taken on same complaint dated 19 jan 2022 and other documents related to complaints etc.

### COMMENTS OF CPIO/South: -

CPIO/South submitted that appellant has filed RTI application for obtaining information, who reported that complaints in question are under enquiry, therefore requisite information was denied u/s 8 (1) (h) of RTI Act.

#### DECISION :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on

record which revealed that the appellant had filed the instant appeal against the reply of CPIO/South with regard to information sought on 03 points i.e. Action taken on the complaint Mr. Ankush Chabra by Lt Col M S dhanoa dated on 04 oct 2020, action taken on same complaint dated 19 jan 2022 and other documents related to complaints etc.

In reply, CPIO/South has denied the requisite information as the complaints were under enquiry at that time.

Insofar as appeal is considered, information sought cannot be supplied at this stage also as complaints are still under enquiry. Thus, CPIO/South has appropriately denied information u/s 08 (1) (h) of RTI Act. Accordingly, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
