

**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-
ESTABLISHMENT & COMM., UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on an online First Appeal bearing no. PODEP/A/E/25/00012 dated 21/01/2025, preferred by Sh. Satish Kumar R/o # 4255, Sector-46 D, Chandigarh, under RTI Act 2005, received in the office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/24/01007 dated 22/12/2024 by CPIO/Establishment and CPIO/Communication.

(2) The appellant, vide his application dated 22/12/2024 under RTI Act 2005, had requested CPIO-cum-DSP/Headquarters to supply information in 05 points related to promotions, duty deployment, work charge and other proceedings of Communication Wing. Nodal Officer/PHQ has transferred the said application to CPIO/Establishment. Further, CPIO/Establishment disposed off his RTI application, vide No. 260/RTI-24/CPIO(Estt.)/UT/3363 dated 21.01.2025 and also transferred the RTI application to CPIO/Communication for partial disposal. CPIO/Communication also disposed off the RTI application, vide No. RTI-66/DSP/Commn./UT dated 16.01.2025.

(3) The appellant, not satisfied with the information supplied by the CPIOs against his RTI application and has filed the instant online appeal to provide complete information.

(4) Comments of CPIOs have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIOs. The information sought by the appellant, supplied by the CPIOs and the order/decision of the undersigned being first appellate authority is given below:-



The SOP of ERSS comprising 26 pages is attached herewith which can be made available after depositing additional requisite fee Rs. 52/-.
