This is an order on online First Appeal bearing no. PODEP/A/E/23/00101dated 08/09/2023, preferred by of Sh. Jagjeet Singh R/o H. No. 5080/2, Modern Housing Complex Manimajra, Chandigarh under RTI Act 2005, received in office online through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/23/00684 dated 14/08/2023 dealt by CPIO/Establishment.

Facts:-

- 2. Vide RTI application dated 08/09/2023, the appellant had sought information on 03 points relating with RDE of Jagjeet Singh (appellant), which are as under:-
 - 1) Complete certified copy of noting file upon which above said request dated 21.6.2023 (P-1018076) followed by reminder (P-106888) has been dealt with or put up before the senior officers.
 - 2) Copy of action taken upon above said request/reminder.
 - 3) Present status of above request/reminder.

- 4. The appellant, not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant online appeal mentioning therein that "The CPIO has provided incomplete information. The appellant had sought complete certified copy of noting file upon which request dated 21.06.2023 (P-1018076) was put up before the senior officers. Whereas, the CPIO has only provided copy of noting page no. 7 dated 01.08.2023 related to reminder dated 21.07.2023 (bearing diary No. P-1068885). Please provide me complete noting pages related to request dated 21.06.2023 (P-1018076) within a week as same are required to prepare defence and suitable replies against RDE," in his RTI application.
- 5. The Comments of CPIO/Establishment-Cum-DSP/Hqrs. were sought through online portal (RTI-MIS), who intimated that the information is already provided to the applicant vide office letter no. 170/RTI-23/CPIO/Estt/UT 35225 dated 24.08.2023 within stipulated period as per provision of RTI Act, 2005.

DECISION

I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Establishment. From the comments and scrutiny of document/paper placed on file, the undersigned found that the information sought by the applicant has already been provided by CPIO/Establishment. The appeal is disposed off, accordingly.
