This is an order in respect of First Appeal, preferred by of Sh. Mohit Deswal S/o Sh Shyambir Singh R/o Lalpur Kadim (166), Village – Lalpur, Tehsil- Palwal, Haryana – 12110 under RTI Act 2005, received in this office through e-mail and speed post No. EH117303309IN, against the disposal of his RTI Application dated 01/08/2024 by CPIO/Establishment, CPIO/PEB and CPIO/Rectt. & Training.

#### **Facts:-**

2. The applicant vide his RTI application dated 01/08/2024, has sought information in 07 points w.r.t. a candidate namely Saurav appeared in the Recruitment of Constable (Executive) (under sports quota) Chandigarh Police. CPIO/PHQ further transferred the RTI application to CPIO/Estb. PEB and Rectt. Training, vide No. 781/RTI/CPIO(PHQ)/UT/PWS dated 06.08.2024 for disposal at their own level. The pointwise information sought by the applicant is as under:-

1. सौरव पुत्र भूपेन्द्र सिंह मूल निवासी गांव बन्चारी तहसील होडल जिला पलवल (हरियाणा) Constable (Executive) under sports Quota Recruitment to 45 Post and Recruitment notice and standing order No. 51/2023 के अनुसार Male General - Merit List S. No 1. Roll No. 20243398 नाम सौरव के द्वारा भर्ती प्रक्रिया के अनुसार प्राप्त अंको की सूची की सत्यापित प्रति जनहित में प्रदान करने का कष्ट करें।
2. सौरव के द्वारा प्रस्तुत किये गये Verification of sports achievement certificate and Age certificate की सत्यापित प्रति प्रदान करने का कष्ट करे।
3. सौरव के द्वारा आपको प्रस्तुत किये गये 10th Pass marksheet and 10+2 Pass marksheet की सत्यापित प्रति प्रदान करने का कष्ट करे।
4. सौरव के द्वारा खेल से सम्बन्धित (Director Sports Officer) पंचकुला कार्यालय के द्वारा जारी सर्टीफिकेट की सत्यापित प्रति प्रदान करने का कष्ट करे।
5. सौरव के पिछले विभाग से छोड़कर आए अनापति प्रमाण पत्र (NOC) व रिजाइन किए गए Letter की सत्यापित प्रति प्रदान करने का कष्ट करे।
6. सौरव को चंडीगढ़ पुलिस द्वारा जारी किये गये Joining Letter ( नियुक्त पत्र) की सत्यापित प्रति प्रदान

करने का कष्ट करें।

7. सौरव के जन्म प्रमाण पत्र की सत्यापित प्रति प्रदान करने का कष्ट करें।

CPIO/Establishment, PEB and Rectt. & Training were dealt the above said application and disposed of in the same in time bound manner.

3. The appellant is not satisfied with the information supplied by the CPIO/Rectt. & Trg. and CPIO/Establishment against his RTI application and has filed the instant appeal mentioning therein that He is not satisfied with the reply received against the point nos. 2,3,5 & 6 i.e. The information is denied being third party information u/s 8 (1) (j) of RTI Act 2005 and information against the points no 1,4 and 7 not received to him.

4. The Comments of CPIO/Rectt. & Trg., CPIO/Establishment and CPIO/PEB were sought, vide No D-765/R/SP/Hqrs. dated 29.09.2024. The comments received are as under:-

**Comments of CPIO/Rectt. & Trg.**

CPIO/Rectt. & Trg. intimated that the said RTI application was transferred by Public Window (PHQ)-cum-CAPIO., vide no. vide No. 781/RTI/CAPIO(PHQ) /UT/PWS dated 06.08.2024, to provide part information u/s 6(3) of Right to Information Act 2005. The requisite information was sought from the In-charge Recruitment Cell and the same was provided to the applicant vide No. RTI-37/DSP/Rectt. & Trg. dated 08.08.2024. Wherein, the desired information w.r.t. CPIO/Rectt. & Trg. was denied under section 8(1) (j).

**Comments of CPIO/Establishment**


CPIO/Establishment intimated that the information w.r.t. point No. 2,3,5 & 6 have been denied being vide office letter No. 162/RTI-24/CPIO/Estt/UT/40997 dated 28.08.2024.

**Comments of CPIO/PEB**

CPIO/PEB intimated that the requisite information against point no. 6 have been denied being third party information as C. Saurav NO. 2757 has given his written submission that his personal information may not be shared with anyone. vide office letter No. RTI-21/PEB Br. dated 13.09.2024.

**DECISION**

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Rectt. & Trg., CPIO/PEB and CPIO/Establishment. The undersigned being First Appellate Authority found that the CPIOs in their comments has submitted that the information sought in RTI application is related to Saurav, who has given in writing "his personal information may not be shared with anyone". Therefore, no more action is required into the matter. The appeal is hereby disposed off, accordingly.
