**ORDER**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on an online appeal preferred by Sh. Ram Kumar Garg R/o H.No.3328, Sector 27D, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/21/00077 dated 25/09/2021, against the disposal of his online RTI Application bearing No. PODEP/R/T/21/00030 dated 27/08/2021.

(2) The appellant, vide his application dated 27/08/2021 under RTI Act 2005, had requested to supply him some information regarding expenses incurred so far with all bills, list of staff members and copy of any interim report and extension in term of the commission in connection with police reforms commission. Nodal Officer- RTI, Chandigarh Police Headquarters, further transferred point No. 03 of the RTI application to CPIO/Accounts, who had disposed of the RTI application vide No. 53/RTI/CPIO (Accts)/2021/U.T/17344 dated 20.09.2021. The appellant not satisfied with the information supplied to him, has filled instant appeal aggrieving that the CPIO has provided incomplete, misleading or false information.

(3) The comments of DSP-cum-CPIO/Accounts have been called for. On perusal of comments submitted by CPIO/Accounts, it is found that the RTI application in question was also transferred to CPIO/PEB and CPIO/Estt. Br. by CPIO/Accounts, vide No. 53/RTI/CPIO(Accts)/2021/16375-77 dated 02.09.2021 for part information on point No. 03, being the custodian of record. Therefore, comments of CPIO/PEB and CPIO/Estt. Br has also been called for.

(4) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Accounts, CPIO/PEB and CPIO/Estt. Br. The information sought by the appellant, information supplied by the CPIOs and decision of the undersigned being first appellate authority are as under:-
