This is an order on online First Appeal bearing PODEP/A/E/23/00109 dated 21/09/2023, preferred by of Pawan kumar Yadav R/o H No. 250, Mouli Jagran, Charan Singh Colony, Chandigarh, under RTI Act 2005, received in the office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application PODEP/R/E/23/00704 bearing No. dated 16/08/2023 by CPIO/Establishment.

## Facts:-

- 2. Vide RTI application dated 16/08/2023, the appellant had sought information regarding recruitment in Chandigarh Police, which are as under :-
  - 1) Information about the official address and contact number of the company to which the recruitment tender was given.
  - 2) Name of the applicant applying with application number CHDPL11042228 and by whom The name of the bank account where the application fee has been paid and all the information related to payment should be there.
  - 3) Application Fee Payment Criteria <u>UPI/315726769539/P2M/nielit.billdesk</u> <u>@hdfcbank/NIELIT</u> which is 06/06/2023 and ECOM 261933094832 NIELIT, which is done on 12/06/2023, please provide the receipt of the same.
  - 4) If any additional application fee has been refunded to the applicant, then the information about the same should also be given as proof. support me.

The said RTI application was dealt by CPIO/Establishment and disposed of, vide No. 186/RTI-23/CPIO/Estt. 36608 dated 06.09.2023.

- 3. The appellant, is not satisfied with the information supplied by the CPIO against his RTI application and has filed the instant appeal mentioning therein that the CPIO may be directed to supply the information sought in RTI application PODEP/R/E/23/00704 within a period of 3 days from the decision of this first appeal".
- 4. The Comments of DSP/Hqrs-cum-CPIO/Establishment were sought, who has intimated that the appellant had requested to supply information in 04 points regarding recruitment of 700 Constable (2023) in Chandigarh Police. As per the report of the concerned branch i.e. E-2, the appellant has been intimated that the candidates may send their query regarding the filling of online application form at email ID <a href="mailto:exmrecruit23@gamil.com">exmrecruit23@gamil.com</a>, vide this office letter no. 186/RTI23/CPIO/Estt/UT/36608 DATED 06.09.2023.

## **DECISION**

I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority is not satisfied with the reply of CPIO/Establishment, as the recruitment of 700 Constables (Executive) 2023 of Chandigarh Police is under process. Therefore, CPIO/Estb. is hereby directed to give a fresh reply to the appellant accordingly, as such, the appeal is disposed of.
