This is an order in connection with online First Appeal bearing no. PODEP/A/E/23/00111 dated 29/09/2023, preferred by of Sh. Mukesh Kumar R/o H No. 150, Sector- 19A, Chandigarh under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his RTI Application bearing No. PODER/R/E/23/00771 dated 02/09/2023 by DSP-HQ-cum-CPIO/Accounts & Proc.

## Facts:-

- 2. Vide RTI application dated 02.09.2023, the applicant through his RTI application had sought information in 06 different points pertaining to the amount deducted from his salary which are as under:
  - i) Provide status of my request and what action are taken on my request letter.
  - ii) Provide reason for deducting salary for time period 23.12.2023 to 25.12.2023.
  - iii) provide reason for not refunding extra deducted amount till now even after informing accounts section multiple times and giving request letter.
  - iv) Provide date when will it be refunded.
  - v) provide detailed calculation of amount recovered from my salary during Jan 23 to Apr 2023.
  - vi) Provide details of concerned official who prepared and approved calculation for amount recovered from my salary during Jan 2023 to Apr 2023.

- 3. The appellant is not satisfied with the information supplied by CPIO/Accounts & Proc., vide no. 109/RTI/CPIO (Accts)/2023/UT/60381 dated 20.09.2023, against his RTI application and has filed the instant appeal mentioning therein that "the Incomplete and Misleading revert received in RTI.
  - A. I have not received correct revert for Point number 3 where reason for delay and not refunding amount deducted amount till now even after informing Accounts section multiple times and giving request letter was asked whereas PIO has given answer for point number 4 in Point number 3 also.
  - B. Some part amount of actual applicable refund amount has been refunded to me after receiving RTI in a hassle without proper calculation but correct refund is still pending for period mentioned in original RTI. There is no basis for Rs. 8487 which is given in reply and not correct".
- 4. The Comments of CPIO/Accounts & Proc. were sought through online portal (RTI-MIS), who has intimated that the point-wise reply of the RTI application supplied to the appellant within the stipulated time period vide no. 109/RTI/CPIO/Accts/2023/UT/60381 dated 20.09.2023.

## **DECISION**

5. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/Hqrs-cum-CPIO/Accts. & Proc. From the perusal of comments and information supplied by the CPIO/Accounts, the undersigned has found that the CPIO has already supplied the information available on the records to the applicant. Hence, no more action is required and the appeal is hereby disposed of.
