#### **ORDER**

The appellant has preferred his 1st appeal dated 05.02.2024 against the disposal of his RTI application dated 02.01.2024 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

## Information sought vide RTI application :-

The appellant vide his RTI application had sought information regarding complaint bearing no. PW/2018-21393.

## COMMENTS OF CPIO/Hqrs:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from I/C HAC who reported that complaint no. PW/2018-21393 has already been transferred to o/o DGP, Haryana vide no. 2458-62/UT/HAC dated 10.04.2019. Applicant was apprised about the same vide letter No. 06/CPIO/Hqrs/RTI-2024 D-63 dated 12.01.2024.

### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding complaint bearing no. PW/2018-21393.

In reply, CPIO/Hqrs has apprised the appellant that complaint bearing No. PW/2018-21393 alongwith all relevant documents, has already been sent to the O/o

Director General of Police, Haryana, hence, requisite information could not supplied to him and the same may be obtained from the concerned SPIO.

So far as the appeal of the appellant is concerned, the appellant has already been apprised by CPIO/Hqrs that his complaint alongwith all relevant documents, has already transferred to the Office of DGP, Haryana, so, he should approach the concerned SPIO for requisite information as requisite information is currently not under the custody of CPIO/Hqrs. Moreover, CPIO/Hqrs is hereby directed to supply the copy of transferring letter to the appellant in accordance with RTI act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
