ORDER

The appellant has preferred his 1st appeal dated 22.01.2025 against the disposal of his RTI application dated 09.12.2024 by CPIO/South-West with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 06 points i.e. Whether Chandigarh Police have power to handover the possession of public land to illegal occupant, If not then whether the department has power to take disciplinary proceedings against the concerned personnel, Whether on 30.05.2020, three police personnel from Beat Box Sector-37 visited the spot at House No. 2119 GF, Sector-37 C Chandigarh, Whether the complaint from Sh. Amarjit Singh was received dated 30.05.2020 to ASP/South, 06.06.2020 to DGP/UT and 12.06.2020 again to ASP/South against the police personnel who handed over the possession of public parking area to Sh. Ashok Kumar and family residing at ground floor House No. 2119, Sector-37 C, Chandigarh, Whether any action has been taken by the department against the said police personnel or Ashok Kumar & family and also provide the copies of documents of police inquiries in this regard.

COMMENTS OF CPIO/South-West :-

CPIO/South-West vide his comments submitted that the RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO PS-39 and points wise reply was supplied to the appellant vide office letter No. 287/RTI/CPIO/South-West dated 25.12.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South-West vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 06 points i.e. Whether Chandigarh Police have power to handover the possession of public

land to illegal occupant, If not then whether the department has power to take disciplinary proceedings against the concerned personnel, Whether on 30.05.2020, three police personnel from Beat Box Sector-37 visited the spot at House No. 2119 GF, Sector-37 C Chandigarh, Whether the complaint from Sh. Amarjit Singh was received dated 30.05.2020 to ASP/South, 06.06.2020 to DGP/UT and 12.06.2020 again to ASP/South against the police personnel who handed over the possession of public parking area to Sh. Ashok Kumar and family residing at ground floor House No. 2119, Sector-37 C, Chandigarh, Whether any action has been taken by the department against the said police personnel or Ashok Kumar & family and also provide the copies of documents of police inquiries in this regard.

In reply, CPIO/South-West provided point wise reply to the appellant vide office letter No. 287/RTI/CPIO/South-West dated 25.12.2024.

Now, as far as appeal is concerned, the appellant has raised his grievances regarding point No. 04 & 05 only (Whether the complaint from Sh. Amarjit Singh was received dated 30.05.2020 to ASP/South, 06.06.2020 to DGP/UT and 12.06.2020 again to ASP/South against the police personnel who handed over the possession of public parking area to Sh. Ashok Kumar and family residing at ground floor House No. 2119, Sector-37 C, Chandigarh & Whether any action has been taken by the department against the said police personnel or Ashok Kumar & family), CPIO/South-West has appropriately disposed of the RTI application by providing the requisite information to the applicant available in the record. Hence, no more action is required to be taken on the instant appeal.

Moreover, appellant has rasied questions/queries through his RTI application, which are not entertainable under RTI Act, as only available information in record can be supplied under RTI Act and the CPIO cannot create information in the manner as sought by the applicant nor can he be expected to do research work to deduce anything from the record.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
