**ORDER**

The appellant has preferred online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00008 dated 03.02.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00002 dated 02.01.2023 by CPIO/East with the contentions that incomplete, misleading and false information was provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI bearing No. PODEP/R/E/23/00002 dated 02.01.2023 had sought information regarding action taken on a complaint lodged by him vide No. ICMS/2023/000050 dated 02.01.2023 regarding affiliation of the Sports School of India Confederation (SSIC) the poster for which was uploaded by Mr. Aman Rawat on the Facebook page of Gramin Football Tournament claiming as the National Development Project affiliated by Sports Ministry.

**COMMENTS OF CPIO/East :-**

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office through online RTI Portal bearing No. PODEP/R/E/23/00002 dated 02.01.2023. Accordingly report of SHO PS Industrial Area was obtained who reported that complaint in question i.e. No. ICMS/2023/000050 dated 02.01.2023 filed by the appellant was under enquiry, so the sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 06-RTI/CPIO/East Dated 27.01.2023. So far as the present status of the complaint is concerned, the same is still under enquiry.

**DECISION :-**


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that CPIO/East after obtaining requisite information from SHO PS Industrial Area denied the requisite information u/s 8(1)(h) of RTI Act, as the complaint bearing No. ICMS/2023/000050 dated 02.01.2023 was under enquiry at that time.

So far as the present status of the complaint is concerned, the same is still under enquiry with SHO PS Industrial Area, Chandigarh. Hence, the requisite information cannot be supplied at this stage also and the same is denied u/s 8(1)(h) of RTI Act.

However, as appellant himself is complainant, therefore, CPIO/East is hereby directed to supply the requisite information to the appellant as per RTI Act, as and when the enquiry into the complaint is finalized.

With these observation the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
