This is an order in online First Appeal bearing no. PODEP/A/E/24/00002 dated 11/01/2024, preferred by of Sh. Bhupesh R/o H No. 575, VPO- Dubaldhan, District - Jhajjar, Haryana under RTI Act 2005, received in this office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/23/01100 dated 27/12/2023 by CPIO/Establishment.

Facts:-

- 2. Vide RTI application dated 27/12/2023, the appellant had sought information in 03 different points w.r.t. recruitment of constable in Chandigarh Police (executive) 2023, which is as under :-
 - 1) Total candidates present for document verification and medical process in different categories.
 - 2) How many candidates got RMD or Failed in D.V. and medical in different categories?
 - 3) How many candidates after conducting all the phase in CP constable finally joined and no. of vacancies remain unfilled categories-wise?

The said RTI application was dealt by CPIO/Establishment and same was disposed of vide no. 02/RTI-24/CPIO/Estt. 1684 dated 10.01.2024.

- 3. The appellant, is not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant mentioning therein that "the CPIO has Provided incomplete, misleading or false information."
- The Comments in this appeal were sought from DSP/Hqrs-cum-CPIO/Establishment, who intimated that the appellant vide his RTI application had requested to supply the information in 03 points related with the recruitment of constable exam-2023 in Chandigarh Police. As per the reports of the concerned branch i.e. E-2, the appellant has been intimated, vide office letter no. 02/RTI-24/CPIO/Estt. 1684 dated 10.01.2024, that the joining of 700 post of constable is still under process.

DECISION

I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority is satisfied with the reply/comments of CPIO i.e. the joining of 700 post of constable is still under process. Therefore, no more action is required in matter, hence, the appeal is hereby disposed of accordingly.
