



**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE
AUTHORITY-ACCOUNTS, UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on an online appeal preferred by Sh. Jasleen S Vohra r/o H.No 677/2, Tower 29, Police complex Dhanas, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/24/00004 dated 12/01/2024, against the disposal of his online RTI Application bearing No. PODEP/R/E/23/01081 dated 19/12/2023 by DSP-cum-CPIO/Accounts.

(2) The appellant, vide his application dated 19/12/2023 under RTI Act 2005, had requested Nodal Officer-PHQ to supply information in 03 points in connection to pension case of his father Lt SI Avtar Singh No. 828/CHG. Nodal Officer/PHQ further transferred the online RTI application to DSP-cum-CPIO/Accounts for its proper disposal at her own level. CPIO/Accounts had disposed of the RTI application on 08/01/2024, vide No. 168/RTI/CPIO/Accounts/2023/ UT/934.


(3) The appellant, being not satisfied with the manner CPIO/Accounts has disposed his RTI application, has filed the instant online appeal to provide complete information.

(4) Comments of DSP-cum-CPIO/Accounts have been called for. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Accounts and the order/decision of the undersigned being first appellate authority is given below:-

In the view of above, CPIO/Accounts is directed to supply the copy of same. The appeal is hereby disposed of.
