ORDER

The appellant has preferred her 1st appeal dated 07.03.2024 against the disposal of his RTI application dated 08.01.2024 by CPIO/Hqrs with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application dated 08.01.2024 had sought information on 04 points regarding complaint dated 10.10.2023 i.e. certified copy of complaint, copy of statements, certified copy of hand written letter of my husband and certified copy of action taken report.

COMMENTS OF CPIO/Hqrs:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from I/C CRU who reported that complaint bearing no. ICMS/2023/026296 has been registered against the appellant and the same is under consideration. Hence, the same was denied to the appellant as per the provisions of section 8(1) (h) of RTI Act, 2005. Applicant was apprised about the same vide letter No. 47/CPIO/Hqrs/RTI-24, D-118 dated 08.02.2024.

DECISION :-


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 04 points regarding complaint dated 10.10.2023 i.e. certified copy of complaint, copy of statements, certified copy of hand written letter of my husband and certified copy of action taken report.

In reply, CPIO/Hqrs denied the requisite information u/s 8(1)(h) of RTI Act as the complaint was under consideration at that time.

Now as far as appeal is concerned, CPIO/Hqrs has asserted that complaint bearing no. ICMS/2023/026296 has now been consigned with HAC Branch after finalization of the enquiry. Therefore, CPIO/Hqrs is hereby directed to provide the requisite information to the appellant as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
