ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on an online appeal preferred by Sh. Jagjeet Singh R/o # 5080/2, Modern Housing Complex, Mani Majra, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/21/00086 dated 22.10.2021, against the disposal of his online RTI Application bearing No. PODEP/R/E/21/00556 dated 21.09.2021.

- (2) The appellant, vide his application dated 21.09.2021 under RTI Act 2005, had requested RTI Nodal Officer PHQ to supply him some information in 04 points regarding request submitted by him to withdraw order No. 7749-69/UT/E-II dated 04.03.2021. CPIO/Establishment disposed of the RTI application, vide No. 164/RTI-21/CPIO (Estt.)/UT/31991 dated 18.10.2021.
- (3) The appellant, not satisfied with the information, filed the instant online appeal aggrieving that the CPIO/Establishment has provided him incomplete, misleading or false information.
- (4) Comments of CPIO/Establishment have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment. The information sought by the appellant in 04 points, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
