ORDER

The appellant has preferred online 1st appeal bearing No. PODEP/A/E/23/00014 dated 10.02.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00005 dated 03.01.2023 by CPIO/North-East with the contentions that how long investigation will take and provide copy of complaint etc.

Information sought vide RTI application :-

The appellant vide his RTI bearing No. PODEP/R/E/23/00005 dated 03.01.2023 had sought information pertaining to complaint No. ICMS/2022/012563 filed by Vivek Singh in PS IT Park against the appellant i.e. Copy of complaint and supporting documents, letter of appearance etc.

COMMENTS OF CPIO/ North-East :-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office through online RTI Portal bearing No. PODEP/R/E/23/00005 dated 03.01.2023 to supply information pertaining to complaint No. ICMS/2022/012563 filed by Vivek Singh in PS IT Park against the appellant i.e. Copy of complaint and supporting documents, letter of appearance etc. Accordingly, requisite information was obtained from SHO PS IT Park and the appellant was informed vide letter No. 01/RTI/CPIO/North-East dated 03.01.2023 that requisite information could not be supplied to him and denied u/s 8(1)(h) of RTI act as the complaint in question was under enquiry at that time.

DECISION :-


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that CPIO/North-East after obtaining report from SHO PS IT Park, denied the requisite information to the appellant u/s 8(1)(h) of RTI Act, as the complaint bearing No. ICMS/2022/012563 was under enquiry at that time.

So far as the present status of the complaint is concerned, as per record of ICMS portal, the same is now consigned to record in HAC branch on 23.02.2023 after completion of enquiry. So the requisite information can be supplied to the appellant.

Accordingly, CPIO/Hqrs is hereby directed to supply the requisite information to the appellant as per RTI act.

With these observation, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
