## ORDER

## Order on First Appeal u/s 19 RTI Act.

This is an order on an online appeal preferred by Sh. Jagjeet Singh R/o # 5080/2, Modern Housing Complex, Mani Majra, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/21/00088 dated 26.10.2021, against the disposal of his online RTI Application bearing No. PODEP/R/E/21/00568 dated 25.09.2021 by CPIO/Recruitment & Training.

- The appellant, vide his application dated 25.09.2021 under RTI Act 2005, had requested RTI-Nodal Officer/PHQ to supply him some information in 03 regarding one request/representation made by him before W/DIG, Chandigarh through official email ID i.e., dig-chd@nic.in to withdraw/quash impugned order of RDE issued vide No.D-613/PA/SSP/Sec. & Trf. dated 04.05.2021 and to provide necessary protection. Nodal Officer RTI-PHQ had transferred the application to DSP-cum-CPIO/HQs. for disposal at his own level but the same was transferred by DSP-cum-CPIO-HQs. to DSP-cum-CPIO/Rectt. & Trg. being the custodian of the information sought in the RTI application. On 25.10.2021, CPIO/Rectt. & Trg. disposed off the RTI application vide No. RTI-14/DSP/Rectt. & Trg.
  - (3) The appellant, not satisfied with the information, filed the instant online appeal aggrieving that the CPIO/Rectt. & Trg. has refused access to information requested.
  - (4) Comments of DSP-CPIO/Rectt. & Trg have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Rectt. & Trg. The information sought by the appellant in 03 points, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
