**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-
ESTT. BRANCH & PEB UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on First Appeal dated 16.01.2024, preferred by Sh. Joginder Singh R/o H.No 553/1, Sector-38A, Chandigarh, under RTI Act 2005, transferred to this office from the o/o SSP/UT-cum-FAA for its proper disposal, as the RTI application dated 15.12.2023 was also found dealt by CPIO/PEB and CPIO/Establishment.


(2) The appellant, vide his RTI application dated 15.12.2023 under RTI Act 2005, had requested Nodal Officer-PHQ to supply him some information in 09 points pertaining to Chandigarh Police. Nodal office PHQ had transferred the RTI application to CPIO/HQs, Sub-division Central, East, South, North East, South West, PEB and Establishment Branch for its disposal at their own level being the custodian of the information sought in RTI application. The appellant is not satisfied with the manner CPIOs had disposed of his RTI application, filed the instant appeal alleging that CPIOs has failed to supply complete information. The undersigned is the First Appellate Authority w.r.t. CPIO/Establishment Branch and PEB only.

(3) The comments of CPIO/Establishment Branch and PEB have been called for. On perusal of comments submitted by the CPIOs, it has come to light that only point No. 05 and 06 of RTI application were dealt by CPIO/PEB and CPIO/Establishment. I have considered the appeal filed by the appellant viz-a-viz comments of CPIOs and the points-wise decision of the undersigned being First Appellate Authority/PEB and Establishment is as under:-

Moreover, the undersigned is satisfied with the reply submitted by the CPIOs i.e. The details/list of officials cannot be provided in view of security reasons and also being third party information.

Point No. 6 Supply list with name and belt No. and posting of police officials who has completed their tenure and still posted in same place.	Point No. 6 Reply submitted by CPIO/PEB:- The disclosure of information has no relationship with any public activity or public interest. Hence, denied u/s 8(1) (j) of RTI Act 2005 being third party information.	Point No. 06 The undersigned is satisfied with the reply submitted by the CPIO/PEB. The appeal is disposed of accordingly.
